AEF Membership Verification

Access to the AEF database to verify your clients AEF membership status. Non-commercial liability insurance is included with individual AEF memberships.

Free Listing on AEF Website

Your stable/facility name will be displayed on the AEF online directory.

Support Certified Instructor(s)/Coach(es)

Hyperlink your Instructor/Coach to the AEF/EC Certified Instructor/Coach profiles.

Display Contact Information

Promote your Stable/Facility Services

List your available disciplines, services and programs offered.

Risk Management

The AEF promotes Stables/Facilities that follow Risk Management practices by requiring your clients to have an individual AEF membership.

Important:

The Alberta Equestrian Federation (AEF) Stable/Facility listing application must be submitted on an annual basis in order to ensure accurate information is provided to AEF members and the public. If an application is not submitted by December 31st of each year, the Stable/Facility will be removed from the list. Should changes be made throughout the year to information provided (e.g. coach(es), disciplines and/or services offered, etc.) contact 1-877-462-6233 or marketing@albertaequestrian.com.

Documents Required to be submitted with Application:

The AEF MUST be prudent about liability issues that could arise from our association with equine activities, therefore, the following documentation is required:

1. A copy of your Stable/Facility's certificate of insurance confirming a minimum of \$2 million liability. Capri Insurance offers preferred rates for AEF members, call 1-800-670-1877. If your insurance expires mid-year, please include a copy of the current policy and forward a copy of the future term policy when renewed.
2. A completed application.

It is highly recommended that Stable/Facility owners take steps to protect themselves from risk by ensuring that all individuals who are actively riding or driving at their facility are members of the AEF. AEF membership covers individuals with \$5,000,000 excess personal liability, \$30,000 accidental death and dismemberment 24/7. Waivers don't always work.
