### Pay It Back Funding Application

**Submission deadline:** November 1

**Response deadline:** December 31

The Alberta Equestrian Federation (AEF) introduces a new funding incentive that will help provide financial support to Wild Rose show organizers. It has been brought to our attention over the years that qualified Officials are expensive, so even though funding has significantly decreased in the past years, it's part of AEF's mandate to help support equestrian activities in Alberta. Show organizers will have the opportunity to apply for funding each year to help offset some of the costs incurred over the year, including officials' fees, associated with holding a competition.

**The AEF will strive to provide funding where available to:**

- Individual show organizers that have sanctioned their show with the AEF during the application year.

### Application process

**The AEF requires the following to be submitted:**

- Completed and signed application form;
- Proof of payment to the Official(s) including total amount (expense form, receipt, invoice, etc.);
- Completed and signed checklist.

Requests for funding will be reviewed by the AEF and a response will be sent to the applicant by December 31.

**Additional criteria:**

- Distribution of funds will be dependent on the number of applications received by the submission deadline;
- Applicants that have not received funding last year may be selected over applicants that did receive funding last year;
- Distribution of funding will be dependent upon certain criteria, including but not limited to total number of Wild Rose shows/year and total amount of Officials fees paid/year;
- All applicants must be current AEF members in good standing prior to applying for funding;
- Applicants cannot apply for funding on behalf of AEF employees or for elected members of the Board of Directors.

**Selection may also be influenced by:**

- The number of years the show organizer has supported the Wild Rose Competition program.

**Eligible Expenses that are considered:**

- Officials Day Fee at Wild Rose competitions during the application year.
